BARREL RACING APPLICATION**

## INFORMATION

1. **ENTRY FEE:** \$20.00 - Must accompany application.
2. **AGE:** Open to barrel racers age 14 - 18 years of age as of January 1st, 2017  
**Copy of birth certificate or government issued photo ID required.**
3. All contestants must wear long sleeve western shirt or blouse and a western hat or approved helmet.
4. All contestants and/or parent/guardian must execute and return with the application the "Contestant Release and Proof of Insurance Form."
5. All contestants must have liability and/or injury insurance acceptable to the Lewiston Roundup Association.
6. All contestants must be of amateur status only. Professional standing will not be accepted. Professional status is defined as an individual in possession of a WPRA permit or card. (WPRA - Women Professional Rodeo Association)
  - a) WPRA rules state that no WPRA card or permit member shall enter or compete in any PRCA rodeo that does not have a WPRA approved barrel race. Penalty for violation is \$1,500.00 and not to exceed \$2,500.00 or possible suspension. (pp 44-45 WPRA rule Book)
7. **FORMAT:**
  - a) Tryouts: Saturday August 26<sup>th</sup>, 2017  
Contestants will make two runs. The top eighteen finishes, based on lowest average times for two runs, will advance to the Thursday, Friday and Saturday performances. Day and order of performance will be based on contestant draw to be conducted immediately after the Saturday 4D Barrel races. Check in time will be 4 pm and tryouts will begin after the races & grounds are reworked.
  - b) The entry fees collected shall be used for "Jackpot" - Payoff based on times.  
Four places will be paid to the lowest times as follows:

1st place:	40% of entry fees collected
2nd place:	30%
3rd place:	20%
4th place:	10%

First place will also be awarded a belt buckle.
8. **BARREL COURSE:** Barrels 1 & 2 will be 90 feet apart and 1 & 3 and barrels 2 & 3 will be 105 feet apart, with a 60 foot score line. There will be a five-second penalty for each knocked over barrel.

The Lewiston Roundup Association reserves the right to make any changes it deems appropriate in procedures, rules and course without notice.
9. All contestants must check in with John Morris no later than 4:00 p.m. on Saturday, August 26th, 2017. Meet at the VFW booth on the North West side.
10. A Health Certification from a Veterinarian is required for all out of state horses. All out of state horses are required to have a current Health Certificate & Coggins. The LRA suggests brand inspections also be readily available in case the Brand Inspector is on-site. Having the paperwork within reach when coming through the participant's entrance would be appreciated.
