

APPLICATION FOR DISCOUNTED FACILITY RENTAL RATES APPLICATION GUIDELINES:

- 1. The applicant must be a 501 c 3 or an education-based organization and must provide documentation.
- 2. Organizations that serve AT LEAST 51% YOUTH (17 and younger) or have at least 51%YOUTH PARTICIPATION will be given highest consideration.
- 3. Approved applicants MUST be up to date on any outstanding rental fees before any discount will be applied.
- 4. Each approved organization will receive no more than <u>5</u> discounted rentals at <u>50%</u> the rental rate, both hourly and daily, in a calendar year.
- 5. Organizations must submit a charitable grant application annually to be considered for the discounted rate.
- 6. Applications must be turned in <u>after</u> October 1st of each calendar year to align with the Lewiston Roundup's fiscal year.
- 7. The Lewiston Roundup Association will approve up to <u>10</u> organizations per year. Applications will be considered on a first-come, first-served basis.

LRA reserves the right to uphold any previously agreed upon rental agreements at our discretion based on what is best for the association
